

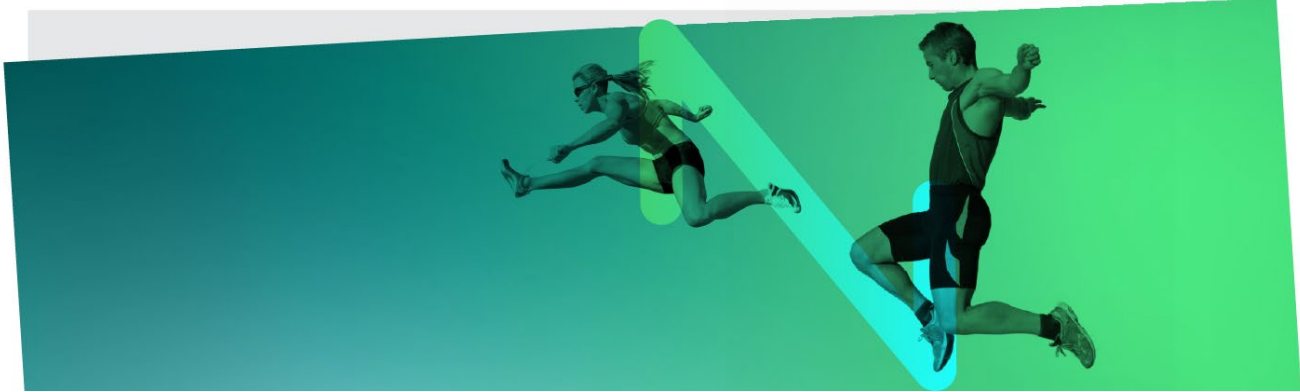
Clean Sport Commitment Statement

All sporting participants have the right to compete in Clean Sport.

The Sport and Exercise Nutrition Register (SENR) adopts the United Kingdom Anti-Doping (UKAD) and World Anti-Doping Agency (WADA) position that cheating, including doping, in sport is fundamentally contrary to the spirit of sport, undermining the otherwise positive impact of sport on society.

To this end, the SENR commits to support Clean Sport in the UK in the following ways by:

- Supporting the mission of UKAD and WADA in achieving clean sport
- Upholding any sanctions placed upon an athlete, or athlete support personnel (ASP), by UKAD or other associated body in accordance with the World Anti-Doping Code
- Supporting the prevention of doping behaviour, including the intentional use of banned substances or methods, or the unintentional ingestion of non-batch tested, contaminated supplements
- Acting upon the condonation, or assistance in any way, of the use of prohibited substances and methods (unless permitted by a Therapeutic Use Exemption) by Registrants in any aspects of their work
- Expecting that all Registrants will contact UKAD should they become aware of an athlete, or ASP, using, or considering the use, of a prohibited substance or prohibited method. - Acting upon breaches of any rules/policies referred to in the SENR Code of Professional Conduct (<https://www.bda.uk.com/uploads/assets/439bf98d-53ee-4518-9970dbc51fbbcb6c/SENR-Code-of-Professional-Conduct-2021-final.pdf>)
- Expecting all Registrants to perform their role in line with the spirit of sport, including the anti-doping rules



How we support Clean Sport

The SENR is integral to sport in the UK by being the professional register for Sport and Exercise Nutrition practitioners. The role of the Register is to regulate the profession of sport and exercise nutrition in the UK by setting and monitoring standards of education and practice for sport and exercise nutritionists.

Our commitment to a Clean Sport environment is that:

- All Registrants will abide by the UKAD policy and procedures in accordance with the SENR Code of Professional Conduct
- All Registrants will be expected to undertake the UKAD Coach Clean e-Learning course as a pre-requisite for Practitioner Registration (<https://ukad.enetlearn.com/Login/?c=82>)
- All SENR Accredited postgraduate courses will be required to integrate completion of the UKAD Introduction to Clean Sport course as part of the course of study (<https://ukad.enetlearn.com/Login/?c=82>)
- The SENR will maintain an up-to-date supplement guidance document in accordance with UKAD advice
- The SENR is committed to working with key stake holders to encourage appropriate CPD opportunities for Registrants
- The SENR will maintain regular communication with UKAD representatives and share relevant UKAD updates and information with Registrants
